## Request for a Polling Location on an Indian Reservation or Colony

NRS 293.2733 and 293.3572 allow Indian tribes to request the establishment of a polling location within the boundaries of an Indian reservation or Indian colony during early voting or on election day. To request a polling location, please complete this form and submit it to the county clerk or registrar of voters in the county where the Indian tribe seeks to establish a polling place. Requests for a primary election polling location must be received by the first Friday in January of an election year. Requests for a general election polling location must be received by the first Friday in July of an election year.
